Start the Roundup with a great Welcome Party and BBQ. This is a time to get together and get acquainted with new and old friends. A steak sandwich, potato salad and dessert will be provided with the cost of the Welcome Party. No host beer and wine bar will be available.

This is an outdoor event with lots of tables and chairs on the grassy area next to the banquet hall. Bring a light jacket for visiting under the evening lights.

Grand Tour

Wednesday, October 5, Starts 9-10 AM

Sierra Foothills and Black Chasm Caverns

The grand tour will start with a meandering tour through the beautiful Sierra foothills as we make our way toward the town of Volcano. At a yet to be determined scenic picnic spot along the way we will enjoy a box lunch and social time. In smaller groups of 20 people, we will stagger leaving times to drive to the nearby Black Chasm Caverns. As participants emerge from the cavern tour we will continue on our scenic tour back to Jackson.

Declared a national natural landmark in 1976, Black Chasm was recognized by the federal government for the abundance of the unusual and rare helicites that grow throughout the cavem. The 50-minute guided walking tour descends into the cave approximately 100 feet below the surface where the temperature is a constant 58°. Guests will view three chambers in the upper levels of this cave where the most spectacular formations grow. A beautiful lake is located in the second chamber about 80 feet below the viewing platform. The cave is vertically oriented with three platforms and five flights of stairs with approximately 163 stairs. While the walk is not especially strenuous, guests with joint or heart and respiratory issues should consider their abilities before participating. An experienced cavern naturalist will guide each group into the cave and explain the varied features as well as the science of speleology as it pertains to this cavern. Those not wanting to enter the cave may still participate on the Grand Tour and visit the gift shop above ground.

IN CONSIDERATION OF BEING PERMITTED TO VOLUNTARILY PARTICIPATE (AT MY REQUEST) IN THE EVENT OF MODEL A FORD CLUB OF AMERICA ("MAFCA"), ITS CHAPTERS, REGIONS AND/OR SPECIAL INTEREST GROUPS REFERRED TO BELOW ("EVENT"), I/We, THE UNDERSIGNED AGREE(S) TO THE FOLLOWING:

- 1. THE UNDERSIGNED HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE MAFCA, ITS CHAPTERS, REGIONS OR SPECIAL INTEREST GROUPS, THEIR EMPLOYEES, OFFICERS AND AGENTS ("Releasees") from all liability to the undersigned, his or her or their personal representatives, assigns, heirs, family members and next of kin ("Releasors") for any loss, damage, or claim therefor on account of injury to the person or property of the Releasors, whether caused by any negligent act or omission or other fault of the Releasees or otherwise while the undersigned is participating in the Event or using any of Releasees' facilities in connection with the Event.
